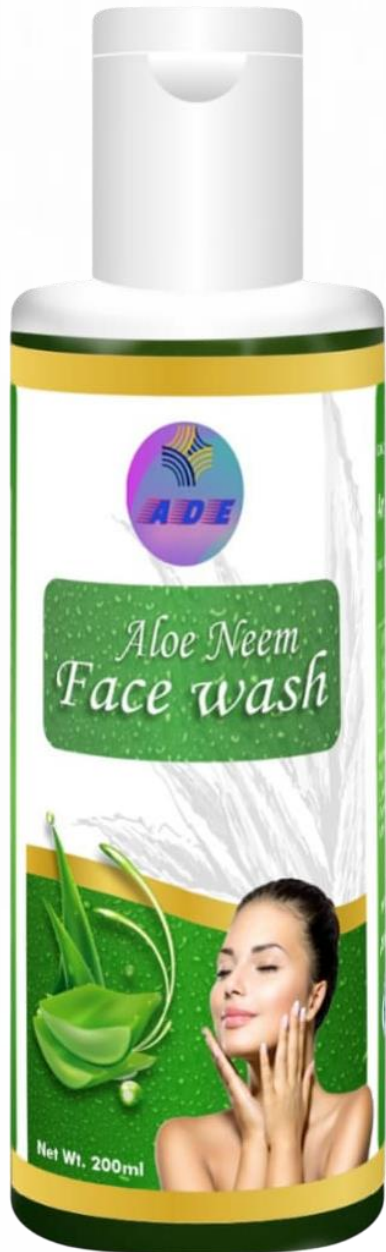

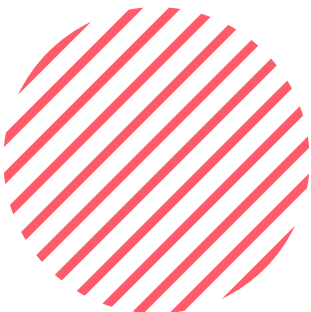

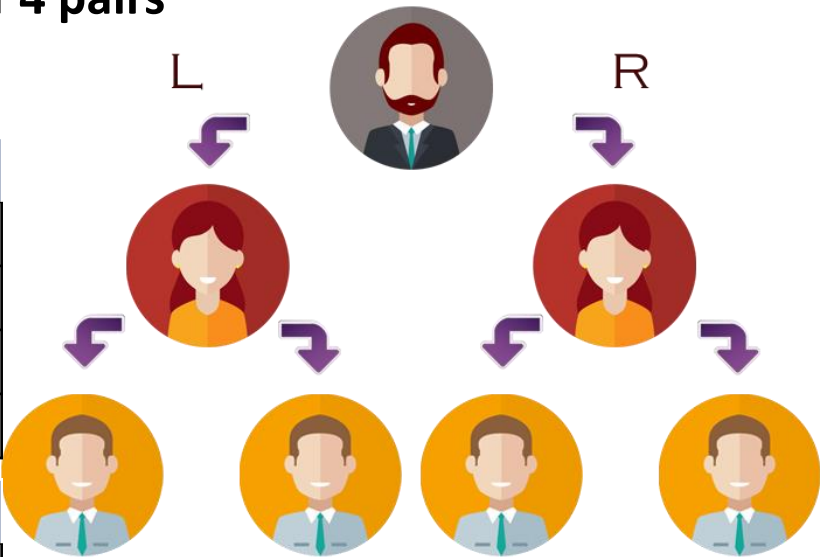

MONTHLY TRAVELING ALLOWANCE
